1. Save Food & Farmers

Pushed into expensive industrial and chemical farming, farmers, now in debt are also being penalised for the ecological damage caused. The plan is to force them out with big industrial farms, insects, lab-made meat/milk/eggs, and factory grown food.

The Irish government push the agenda of big corporations, that use a fake 'Green Agenda' meanwhile ignoring and blocking creative solutions offered by scientists and farmers.



What Will the War on Farmers & Food Mean for Irish people

- ❖ Our unique rural Irish society, culture and businesses ruined.
- ❖ Money going to global corporations not local areas.
- ❖ 80% of people controlled in large urban centres, food produced in huge labs/industrial farms/factories.
- ❖ Nutritionally empty, highly processed food full of toxins/fertilisers/pesticides and INSECTS
- ❖ Soil health/ecology and human health devastated.
- ❖ The destruction of Irish Fishing will continue.



What Can You Do

- ❖ Resist the treaty giving the World Health Organisation (WHO) power to decide and enforce Irish Agricultural Policies (for climate health etc.)
- ❖ Support Farmers & Lobby politicians.
- ❖ Unite Against Globalisation. Buy local & Irish food, straight from farms and markets if possible. Spend cash
- ❖ Ask why farming not industry is held responsible for carbon emissions.

Some of the Many Anomalies in the 'Green Agenda'

- ❖ An unfair system of counting farmer's carbon and methane, meanwhile no carbon tax on private planes/yachts /**data centres**.
- ❖ Huge ecological footprint from lab-made & imported food & insect factories

Food production is our most vital use of land. The way forward is land regeneration, creative farming, and small biodiverse farms. A country unable to feed itself risks FAMINE.

The United Nations (UN) & The World Economic Forum (WEF)

The UN & WEF are unelected bodies mostly funded by private corporations

The **UN & WEF 2021 UN Food Summit** was boycotted by 70% of small farmers for only representing corporate interests. The **WEF** a private exclusive club representing big corporations, (causing most of the world's ecological damage), pretend to offer Green Solutions but really only benefit members while increasing Power, Profit and Control. The **WEF** groom politicians (*Young Global Leader* programme etc) and boast of infiltrating most governments (treason is putting another agenda before that of your own country), (members include Leo Varadkar). The **WEF** predict that by 2030 'You will own Nothing and be Happy' this will happen under a regime of total surveillance and control. The elite will of course own everything. The EU/UK/USA etc are already introducing these control systems.



2. Protect Children

Primary school children are increasingly being sexualised, this used to be considered grooming but now it has the backing of our government, schools and libraries. *This Book is Gay* in the under-12 section of libraries describes the pleasure of anal stimulation and says that porn (and multiple partners) is fun. Recently Isle of Man parents were shocked that their 9-year-olds were traumatised by a blow-by-blow description of a sex-change operation and told that there are 72 genders. It has emerged that some Irish counselling services/groups are biased towards pushing children to change gender. While there is a very small percentage of people who are genuinely trans and for whom the physical trauma of cutting off body parts, becoming infertile (after a few months of hormone treatment) and being on medication every day is worth it, it is a huge decision and no physically irreversible decisions should be taken before age 18. USA figures show that 40% regret surgery while Norma Foley wants to allow it for 16-year-olds without parental permission.

3. Amendment 39 & The Homeless Crisis

The Irish govt. caused the homelessness & housing crisis by the following policies.

- ❖ Incentivising multinationals and allowing vulture funds (banned in other countries) to buy 95% of Irish homes (2019) increasing rents and house prices.
- ❖ Not providing social/affordable housing.
- ❖ Not sorting rent control and unfair evictions
- ❖ Giving public land to private developers and making it impossible for local authorities to build.



Q: Why have successive Governments not built sufficient affordable housing.

A: It does NOT serve the interests of international financial corporations.

AMENDMENT 39 OF THE CONSTITUTION (vote this year, no date yet)

A bill to ‘delimit’ people’s private property rights for the ‘common good’ to provide housing for ‘Residents of Ireland’. This will mean confiscation/compulsory purchase of homes, land etc to give housing to **anyone living here** (not just citizens)

A right to adequate housing is already established in international law, other countries have legislated for housing while keeping the right to private property.

You will only have the right to be *housed* somewhere, *not* the right to own your home. Irish homes would be owned by global corporations. Multibillionaire foreign investors of course won’t have their property seized

4. Cost of Living Crisis

- ❖ Fuel is 52% govt. tax; the ESB (95% govt owned) has hugely increased profits in 2022, meanwhile politicians have raised their salaries multiple times since 2018.
- ❖ 2022 had a record overall poverty rate; increased from 13.3 % to 19 %.
- ❖ BlackRock and Vanguard may own everything by 2028 giving *them* a monopoly on prices and *us* no choices, resist now while you can.

What Can You Do:

*Keep money in the local area, use cash, buy local from independent shops not global corporations.

*Refuse to use automated checkouts (replacing people) and smart meters (higher prices at peak times).

* Don't comply with future lockdowns/restrictions (in the name of climate change perhaps) keep your business open, keep the economy going. Lockdowns destroyed communities economically, socially and mentally.



The govt. has led us to believe that the cost-of-living crisis is caused by the war in Ukraine whereas it is really a cost of lockdown, government. greed and inflation crisis.

5. Crime & Overpopulation

For decades foreign nationals have been welcomed and integrated into Ireland. Real refugees from war torn countries are still welcome as long as we can accommodate them without ruining our own country, this point has now been reached. Never before have refugees been given more rights than Irish citizens, (this is anti-Irish racism e.g. putting non-citizens to the top of the queue for getting a house, social benefits etc; most other countries do not do this).

There is an increase in sex crimes due to an increase in single, male migrants from countries with little respect for women. From 5/1/2023 to 19/2/2023 (46 days) 32 of these men were convicted of rape/sexual assault (3 serial rapists, 2 gang rapes, 5 taxi drivers; assaults on a Down Syndrome girl and young girls of 10-, 13-, 14-, and 15-year-olds) Many cases have not been reported to Gardai. The media/Gardai are complicit in hiding what happens. Gardai forced a Dunganarvan family to remove a Facebook post warning women to be careful after an attempted gang rape of a family member.



What Can You Do: Tell TDs and local government that you support the right of homeless Irish/refugees already here for many years to be housed first and that you do not agree with uncontrolled migration especially those unvetted.

6. Vaccine Victims Must be Compensated

In December 2019 a judge ruled that the Irish Government must set up a compensation board for those who would suffer covid vaccine damage. Even though vaccine injury numbers are now dramatically high (myocarditis, strokes, clots, Bell's Palsy, sudden death etc, full list on HSE website) this has not been done and vaccine injured people have nowhere to turn.
